Observed expired cheese sauce in pantry.----Staff removed for disposal.----Corrected on site.

CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.

Violation #16. Food-contact surfaces; cleaned & sanitized

Observed can opener with build up of substances on blade and surrounding areas.---Staff removed for deep cleaning.

CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.

Violation #21. Hot holding temperatures

Observed one pan of black beans temped 117F. Other pan temped 179F. Out of temp pan removed for reheating. Re-temped 180F.----Corrected on site.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
